HIGH TECH SOLUTIONS

Unique Lighting Kit (Yes, that is the correct spelling!) By Valerie Weil

I saw an advertisement of this and thought it would be perfect for many of our document examiners.

If you are using your cell phone to capture document images these days, this portable device offers you a better way to obtain the sharp images you need, with better lighting and a hands-free picture taking ability.



The device is called "Uniqu Lighting Kit" (no "e" on that

first word, that's their name brand.) It's a simple extension device that holds your cell phone for taking images hands free (no shaky or blurry images) and provides 7 levels of overhead lighting for the sharpest photograph images you can capture with your phone.

It folds into its own base (8.27" x 3.15" x 2.48"), so it is completely portable. It can fit into your briefcase or purse. It comes with a Micro USB Charging cord (which can fit into your computer), or it can send images through bluetooth. And it accommodates nearly all smart phones (both apple and android) today. If you need to use an iPad instead of a cell phone, they also offer one of those stands on their website.

This device has a remote control to power on the lights, power up the lights (there are seven levels of lighting to help avoid unwanted shadows or uneven lighting). You can even use this remote to take the image onto your cell phone without you having to touch the phone. So, it's a hands-free snapshot for better clarity.

This lighting and stand equipment have an extension arm that can elevate your cell phone up to 38.9" over your document to ensure you capture the entire page, or as close as 7" above it. You can use the arm for overhead image taking. And, its head can rotate 360 degrees - which is perfect if you are looking to do side angle images.


